Greater Salisbury Bowling Senate Tournament Rules

1. This tournament shall be sanctioned and opened to all members of TNBA and USBC. The tournament shall operate under the rules of USBC and TNBA.
2. Non-USBC members may enter by paying a \$21.00 membership fee. Non-TNBA members may enter by paying a \$15.00 membership fee.
3. This tournament shall commence on Saturday February 23, 2008 and run for two (2) consecutive weekends ending Sunday March 2, 2008. Squad times are: 12 noon; and 2:30 pm (Teams). 11:00am, 12:30pm and 2:00pm (Doubles). Check in time is one (1) hour before scheduled time to bowl.
4. Pre entries will be accepted. All entries will be treated on a first come first serve basis and entries must have complete entry fee upon receipt. No personal checks or cash will be accepted through the mail. Send fees by money order, bank check or certified check. Cash only will be accepted at the tournament site and entrants must pay entry fee with application...Make certified checks or money orders payable to Greater Salisbury Bowling Senate.
5. Teams must be mixed (at least one-man and one woman- 4 total). Doubles - two women; two men; or mixed. Minimum of two (2) teams will constitute a squad. Optional singles available while bowling doubles.
6. All entrants must use the highest USBC 2006/2007 season yearbook average. If no book average, use highest USBC 2007/2008 current average (21 game minimum). As of the date of participation in this tournament. Participants must verify average. All others will bowl scratch (210). The tournament director reserves the right to re-rate entering average as deemed necessary.
7. It shall be each bowler's responsibility to verify the accuracy of his/her average. Failure to use the correct average shall disqualify score if submitted average is lower. Prize winnings will be based on the average submitted at the tournament if it is higher than the correct average. (USBC rule 319a-3). There will be no refunds on disqualifications.
8. The 10 pin rule and 15 pin rules (319a-2 and 319e) will not apply but USBC rules 319a-4 and 319d) will apply.
9. Handicap will be 80 % of (210 minus average) for men and women.
10. Re-entries are permitted. You may cash only once with same partner. In the singles event a bowler may cash only once in the prize list for position standing.
11. All entries will bowl three (3) games on the same pair of lanes with total pins plus handicap deciding the tournament winners. Optional singles will use the same three games bowled for doubles.
12. Prize fund will be returned 100%. Prize fund ratio will be at least one for every ten entries.
13. Should a tie occur for first place after all teams have completed the final squad on March 2, 2008, the two teams will split first and second place prize fund.
14. The decision of the Tournament Committee shall be final on any and all disputed unless and appeal is made in accordance with rule 329.
15. The tournament Director reserves the right to disqualify any entrant not in compliance with the rules of USBC and the TNBA.
16. All other USBC and TNBA rules will apply.
